B \_\_\_\_\_ Additional fees/adjustments may apply as rental rates are based on information provided. Renter is not covered by The Salvation Army liability insurance.

C \_\_\_\_\_ 10% of the estimated rental is due upon signing the property use agreement. The remainder is due 7 days prior to the event start date.

D \_\_\_\_\_ The following cancellation policy will be followed and enforced: (Day of the party counts as day 1) 30 or more days prior to the booked date - 100% refund. 8-29 Days Prior to the date - 50% refund. Up to 7 days - 0% refund.

E \_\_\_\_\_ Using any space not included in the rental agreement and invoice is prohibited.  
INITIAL

F \_\_\_\_\_ The scheduled rental time includes load in and striking. Any variance will be billed to the renter at the standard rates. The Kroc center reserves the right to charge additional custodial or security fees for events that exceed 100 people. We will allow 30 minutes before & After the party for you to "set up" and to "clean up".

G \_\_\_\_\_ I agree to the costs, dates and times included with this addendum.

H \_\_\_\_\_ Preliminary guest counts are due at contract signing. You may adjust your guest count up to 5 business days prior to the event for contractual purposes. If a guarantee is not received by this date the event host will be served and charged based on the original details of the signed contract or the actual attendance whichever is greatest.

I \_\_\_\_\_ The Kroc center reserves the right to take pictures of the event for use on Kroc center promotional material. This can be waived if expressed in writing to the Kroc center marketing department, attention Center Director.

J \_\_\_\_\_ All decorations must be pre-approved. Confetti and hanging items from the ceiling is prohibited. Items hung on the wall must be hung with painters tape.

K \_\_\_\_\_ Any entertainment / outside vender must be approved in writing by The Kroc Center.

L \_\_\_\_\_ Adequate adult supervision is required for children and teenage groups.

M \_\_\_\_\_ If there is a fecal incident in the pool, we are mandated by Maricopa County Code to shut down for a minimum of one hour. In serious cases, it may be shut down 24 hours.

N \_\_\_\_\_ If there is an Electrical power outage, once electricity is regained and the pool area is deemed safe and pool chemicals have stabilized, the Director for Aquatics and or Head Lifeguard will reopen the pool.
